3. Hon'ble Vice Chancellor Prof. Karunesh Saxena gave a presentation on NEP 2020 & encouraged all faculty members to read the NEP 2020 66 Pages document which available online.

4. Minutes confirmed of last academic council which were held on 6 July 2020.

- 26. In view of deteriorating Covid Conditions (Omicron Variant), it was decided by the Academic Council to conduct classes or/and exams online if Government so directs.
- 27. Hon'ble Vice Chancellor instructed COE to submit Exam Manual for Approval by the Council.
- 28. Admissions related Changes approved by the Council:
  - a. Admission last date is 31st Dec 2021 except PG Courses
  - b. Minimum intake will be for UG 10(7 with permission of president)
  - c. Minimum intake will be for Masters 05(3 with permission of president)

Note: The Minimum intake rule will be applicable from the session 2022-23.
